I hereby agree to indemnify and hold harmless the EHS, its employees, directors and agents from any and all claims, or claims by any member of my family or any other person accompanying me to a function of the EHS, or while attending the premises thereof, as a result of any action by any dog(s). _____ Init.
4. I hereby represent that my dog(s) is of good health and has not been ill with any known contagious diseases within the last thirty days and that the health of the dog(s) is my responsibility. _____ Init.
5. I hereby represent that all required vaccinations (rabies, bordetella, distemper and parvovirus) are up to date and will notify staff of any known medical conditions whether suspected or confirmed by a Veterinarian. _____ Init.
6. My animal has not punctured or shown aggression or threatening behavior towards any person or any other dog. _____ Init.
7. I further understand and agree that the EHS will not be liable for any ailment that may or may not develop with my dog(s), including, but not limited to, sickness, disease, injury, running away and death. _____ Init.
8. The hours of operation of the EHS' Muddy Paws are 7am-8pm Mon-Fri, and 8am-6pm Sat & Sun. I agree that the EHS retains the right to amend the hours of operation at any time. _____ Init.
9. I agree to retrieve my dog(s) prior to closing time. It is hereby acknowledged that that should I fail to pick up my dog(s) before closing time a late fee will be charged to myself at the rate of \$1.00 per minute late, up to a maximum of \$30.00 to be paid in cash upon retrieval of my dog(s) from The Edmonton Humane Society.

10. My dog(s) may be videotaped, photographed and or recorded. The Edmonton Humane Society shall be the exclusive owner to the results. _____ Init.
11. The EHS reserves the right to discontinue, reschedule, or cancel a dog(s) appointment for any reason at anytime. _____ Init.

The Edmonton Humane Society for the Prevention of Cruelty to Animals (the "Society"), a non-profit organization incorporated under the *Alberta Societies Act*, recognizes that it is bound by the Alberta *Personal Information Protection Act* insofar as it collects, uses or discloses personal information in connection with any commercial activity carried out by the Society. Commercial activities include sales at the retail store, EHS Doggie Daycare, Muddy Paws, adoptions, euthanasia services, admittance of animals, pet training classes and the sale of personal information of adopting parents to the City of Edmonton. Personal information collected from donors and volunteers does not fall under the Alberta *Personal Information Protection Act*, as there is no "commercial" activity involved. In this respect the Society agrees not to share the names of volunteers or donors with any third parties.
