

2024 MADE for PETS



VENDOR APPLICATION FORM

MADE for PETS is Edmonton's pet-themed handmade market hosted by the Animal Care & Control Centre (ACCC) and the Edmonton Humane Society (EHS). Vendors are invited to rent a booth space to sell handmade wares, with all vendor fees being allocated to support EHS.

All participating vendors are required to sign the MADE for PETS Vendor Application Form. In addition, all vendors must adhere to the event policies and vendor criteria.

EVENT DETAILS

The 2024 MADE for PETS market will be held on Sunday, November 17, 2024 from 10:00 AM - 4:00 PM.

- This event will be hosted indoors in the Edmonton Humane Society's Canine Enrichment Centre.

- The vendor application deadline is Thursday, November 7, 2024.
- Cancellation policy: To receive a full refund, cancellation must be provided prior to Thursday, November 14, 2024.
 No vendors will be eligible for a full or partial refund after this date.

VENDOR CRITERIA

To be eligible for attendance, all vendors must meet the following criteria:

- Products sold by the vendor should be pet or animal themed.
- No vendor is permitted to sell products containing CBD oil, as per Health Canada and the Cannabis Act
- All products sold by the vendor must be handmade. No mass-produced products.
- All products sold by the vendor are made in Canada.
- All products sold by the vendor have been designed, created, and manufactured by the vendor.
- Vendors must have tangible products available to showcase for present or future purchase within their booth space.

All vendor applications will be reviewed and approved based on a variety of factors. If you have questions regarding the criteria involved in this decision, feel free to contact the event organizers.

Priority will be given to local vendors, however all vendors are welcome to apply.

EVENT POLICIES

General

- No vendor can be present unless registered.
- Vendors attending must not share space, tables, or booths. Only one vendor per booth.
- Any vendor participating cannot collect donations or engage in any specific philanthropic promotion.
- Vendors are not permitted to provide demonstrations of any products or services outside of their booth space without permission.
- Absolutely no smoking or e-cigarettes are permitted inside the building.
- Vendors are not permitted to bring animals, due to the unpredictability and stress of the environment.
- Vendors are not permitted to sell or adopt any animals out during the event.

Booth Requirements & Equipment

- An 8'x8' space will be reserved at the venue for each confirmed vendor.
- A table and 2 chairs per booth will be provided.
- Vendors will be responsible for providing a tablecloth (if required) and any other necessary setup supplies.
- A power source will not be available for vendors within the booth space.
- There is only an EHS Guest WiFi available.

Setup & Teardown

- Setup will take place on Sunday, November 17 from 8:00 AM and must be completed by 9:30 AM. No vendors may begin to tear down until 4:00 PM on Sunday, November 17.
- Once unloaded, all vendors must park in designated parking lots.

No vendor may be in violation of any policies, as determined by the event organizers. If any vendor is found to be in violation of these policies during the course of the event, they will be asked to modify their operations at the event or have their vendor status revoked, and the display removed

Vendors will be contacted prior to the event with specific event, setup, and teardown instructions.
